#### MINUTES OF MEETING TISON'S LANDING COMMUNITY DEVELOPMENT DISTRICT

The regular meeting of the Board of Supervisors of the Tison's Landing Community Development District was held Thursday, May 8, 2025, at 6:00 p.m. at the Yellow Bluff Amenity Center, 16529 Tisons Bluff Road, Jacksonville, Florida.

The following is a summary of the discussions and actions taken at the May 8, 2025, meeting.

#### FIRST ORDER OF BUSINESS Roll Call

Mr. Laughlin called the meeting to order at 6:00 p.m. and called the roll.

#### SECOND ORDER OF BUSINESS Public Comment Regarding Agenda Items

There being no members of the public present, the next item followed.

#### **THIRD ORDER OF BUSINESS**

**A. District Engineer** There being nothing to report, the next item followed.

#### B. District Counsel

There being nothing to report, the next item followed.

#### C. District Manager

**Staff Reports** 

At the request of a board member, Mr. Laughlin asked the board to state their name and whether they are in favor or against each motion.

Mr. Evans stated that he'd also like the minutes to reflect how each board member voted.

#### D. Amenity Manager

#### 1. Report

Ms. Myers presented the Amenity Manager's report. Next, she provided the results of a survey sent to the residents for the purpose of understanding the interest and/or need for speed bumps. The results showed that 66% of the respondents support the HOA and/or CDD fees funding installation of speed bumps. Tisons, Dowing and Magnolia were the three spots that the respondents said speed bumps were most needed.

#### 2. Amenity Furniture Estimates

My. Myers presented examples of furniture from other communities along with color and material options and pricing estimates.

On MOTION by Ms. Schaffer seconded by Ms. Timmons to approve purchasing 40 Chippendale dining side chairs, 3 barstool chairs and 6 white Aquaba round tables by roll call vote: Supervisor Timmons: Aye Supervisor Alford: Aye Supervisor Schaffer: Aye Supervisor Evans: Aye Supervisor Waldhauer: Aye Motion passed 5-0.

On MOTION by Ms. Schaffer seconded by Ms. Timmons to approve declaring the current amenity furniture as surplus assets and either donate to a charity organization or dispose of the furniture by roll call vote: Supervisor Timmons: Aye Supervisor Alford: Aye Supervisor Schaffer: Aye Supervisor Evans: Aye Supervisor Waldhauer: Aye Motion passed 5-0.

#### E. Field Operations Manager

Mr. Harden presented the Operation Manager's Report.

#### FOURTH ORDER OF BUSINESS Approval of Consent Agenda

Copies of the minutes, financial statements, and check register totaling \$32,767.83 were

included in the agenda package for the Board's review.

On MOTION by Ms. Timmons seconded by Ms. Schaffer to approve the consent agenda by roll call vote: Supervisor Timmons: Aye Supervisor Alford: Aye Supervisor Schaffer: Aye Supervisor Evans: Aye Supervisor Waldhauer: Aye Motion passed 5-0.

#### FIFTH ORDER OF BUSINESS

#### **Discussion of Speed Hump Cost Estimates**

Ms. Meyers created a proposed map of where the speed humps should be located. The speed humps would be placed every 400-feet on Tisons Bluff, Dowing and Magnolia. There would be exceptions with the distance between if it would interrupt someone's driveway, or an intersection.

Mr. Laughlin added that he has a message into Commissioner's Gaffney's office to ask about the possibility of funding assistance for the speed humps.

Mr. Evans presented cost estimates for the speed humps, that in total ranged from \$139,985 to \$318,345.

Ms. Timmons cautioned that she previously spoke to a county engineer that advised there are many other factors involved before the speed humps could be approved including a meeting with the residents to get their feedback and a traffic study.

Mr. Laughlin stated that some other communities have hired off-duty officers to patrol the roads as an alternate solution for speeding and it's been successful. He estimated the cost to be around \$65 per hour for a minimum of three to four hours. Ms. Waldhauer suggested moving the speed limit radar signs to different locations.

Ms. Harden suggested looking into the HOA pursuing speed humps versus the CDD.

Mr. Laughlin will bring information regarding off-duty officers along with any response from Commissioner Gaffney to the next meeting for further discussion on this topic.

#### SIXTH ORDER OF BUSINESS

#### Consideration of Resolution 2025-05, Approving the Proposed Budget for Fiscal Year 2026 and Setting a Public Hearing Date for Adoption

Mr. Laughlin provided an overview of the fiscal year 2026 budget, noting there is no increase in assessments being proposed.

Ms. Meyers informed the Board that there would be a significant cost difference if the District switched to Waste Management as its refuse provider.

On MOTION by Ms. Alford seconded by Ms. Timmons to approve terminating the contract with Republic Services and entering into a contract with Waste Management by roll call vote: Supervisor Timmons: Aye Supervisor Alford: Aye Supervisor Schaffer: Aye Supervisor Evans: Aye Supervisor Evans: Aye Motion passed 5-0.

Mr. Evans proposed sending notices to every homeowner regarding the assessments whether they increase or not to ensure they're aware of the assessments.

Mr. Laughlin stated that a bulk mailer would be used to send such notices, which typically runs around \$1,000 to \$2,000.

On MOTION by Ms. Waldhauer seconded by Ms. Alford to approve not sending a letter this year to every homeowner regarding there not being an increase in assessments by roll call vote: Supervisor Timmons: Aye Supervisor Alford: Aye Supervisor Schaffer: Aye Supervisor Evans: Nay Supervisor Waldhauer: Aye Motion passed 4-1.

Mr. Evans requested a list of every homeowner be provided to him.

Mr. Laughlin responded that he could provide a list, however there are certain folks that are exempt from public record, so they will be excluded.

On MOTION by Ms. Alford seconded by Ms. Timmons to approve Resolution 2025-05, approving the proposed budget and setting a public hearing for July 10, 2025 at 6:00 p.m. at the Yellow Bluff Amenity Center by roll call vote: Supervisor Timmons: Aye Supervisor Alford: Aye Supervisor Schaffer: Aye Supervisor Evans: Nay Supervisor Waldhauer: Aye Motion passed 4-1.

#### City of Jacksonville's Role

The City of Jacksonville oversees the installation of 35 speed humps on Magnolia Way, Tison's Bluff, and Dowing Creek in Tison's Landing CDD through regulation and permitting but does not fund, install, or maintain them. The Traffic Engineering Division (904-630-CITY) reviews traffic studies, enforces standards (e.g., 3–3.5-inch humps, W17-1 signage per MUTCD Section 2C.29 and Chapter 316, Florida Statutes), and coordinates with Jacksonville Fire and Rescue (904-630-0529) for emergency access. The Development Services Review Group (904-255-8310) issues Right-of-Way Permits, requiring drawings and inspections, and verifies contractor qualifications. Tison's Landing CDD contracts all contractors and covers costs, consistent with projects like Girvin Road (2024).

#### **Clarification for Local Roads**

- The federal MUTCD applies to local roads, adopted by Florida and enforced by the City, requiring two W17-1 signs per hump. City standards may add requirements (e.g., sign placement), as seen in San Marco (2023).
- Costs for traffic study (\$15,000-\$30,000), permitting (\$360-\$1,620), and traffic control (\$3,750-\$11,250) reflect three roads

Good Afternoon,

I have sent this to Traffic Engineering. Here is what options are available and the requirements.

#### All-Way Stops:

Many residents request the installation of all-way stops to control speeding. National traffic engineering standards do not allow the City to install all-way stops for this purpose. All-way are only installed at locations that have high traffic volumes, crash patterns, or site distance problems. More information is available at this link: <u>Traffic Signs FAQ</u>. The most common forms of traffic calming are speed humps or reduced speed limit signs.

#### **Reduced Speed Limits:**

The default statewide residential speed limit is 30 mph. Your neighborhood may have the speed limit reduced by petition. The lowered speed limit is typically 25mph or 20mph depending on your pavement width. It is important to note that reduced speed limit signs may not be effective without JSO enforcement. Traffic Engineering will determine where and how many signs are installed. The neighborhood is responsible for the full cost of the signs. Each sign costs \$140.

#### Speed Humps:


Your neighborhood may have speed humps installed by petition. Speed humps are designed in a such a way that vehicles must slow down to 15-20mph as they pass over them. Traffic Engineering will determine where and how many speed humps are installed. Speed humps can only be installed on public residential roads. Roads classified as collectors or arterials are not eligible. The neighborhood is responsible for paying the cost of each speed hump. Each speed hump costs \$4,124.00.


#### **Petition Process:**

- 1. The petitioner submits a service request. Requests should include the streets on which traffic calming is needed, the type of calming, and a contact person.
- 2. Traffic Engineering performs an investigation. If the streets are eligible for traffic calming, then Traffic Engineering sends a sketch and cost estimate to the requestor.
- 3. The requestor contacts their City Council Member and requests a public meeting.
- 4. At the public meeting Traffic Engineering explains the advantages and disadvantages of the project. JSO and JFRD will explain how the project will affect emergency response times.
- After the public meeting, Traffic Engineering will send an invoice for the project. Payment must be received within 60 calendar days of invoicing.
- 6. After payment receipt, Traffic Engineering sends 2 written notices to the affected property owners. The property owners may respond by expressing approval or disapproval of the project. Nonresponses are considered approvals.
- 7. Traffic Engineering checks that 75% of affected property owners approve after the 60-day response window.
- 8. If 75% of affected owner's approve, the City will install the project.

\*Other traffic calming methods such as traffic circles or reduced lane widths may also be considered.

#### **RESOLUTION 2025-06**

A RESOLUTION BY THE BOARD OF SUPERVISORS OF THE TISON'S LANDING COMMUNITY DEVELOPMENT DISTRICT CLASSIFYING CERTAIN TANGIBLE PERSONAL PROPERTY OF THE DISTRICT AS SURPLUS AND AUTHORIZING THE DISTRICT MANAGER TO SELL OR DISPOSE OF SAID PROPERTY AS EXPEDITIOUSLY AS POSSIBLE IN ACCORDANCE WITH CHAPTER 274, FLORIDA STATUTES; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE

**WHEREAS**, the Board of Supervisors of the Tison's Landing Community Development District (collectively, the "District") owns certain tangible personal property, as more fully described in Exhibit "A", incorporated herein and made a part hereof (the "Property"); and

WHEREAS, said Property is no longer useful to the District and the continued use of such Property is no longer economical or efficient, or said Property no longer serves a useful function; and

WHEREAS, the District desires to classify and declare said Property on Exhibit "A" as surplus property; and

WHEREAS, the District desires to authorize the District Manager to sell or dispose of said Property as appropriate and in accordance with Chapter 274, Florida Statutes, governing the disposal of surplus tangible personal property by local governments, including special districts.

#### NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF SUPERVISORS OF THE TISON'S LANDING COMMUNITY DEVELOPMENT DISTRICT, THAT:

**Section 1.** The above recitals are true and correct and incorporated herein as if set forth in full herein.

**Section 2.** The District Manager is hereby authorized to take the necessary and appropriate steps to sell at auction or dispose as appropriate and in accordance with Chapter 274, Florida Statutes, said Property, including, but not limited to, contributing the Property to a non-profit entity or placing or delivering the Property to an appropriate entity for disposal as bulk trash. The Board of Supervisors hereby ratifies and approves any disposition of the Property previously taken by the District Manager consistent with this Resolution.

**Section 3**. All sections, or parts thereof, which conflict herewith, are, to the extent of such conflict, superseded and repealed. In the event that any portion of this Resolution is found to be

unconstitutional or improper, it shall be severed herein and shall not affect the validity of the remaining portions of this Resolution.

#### REVENUES

#### Special Assessments-Tax Roll

The District will levy a Non-Ad Valorem assessment on all sold and platted parcels within the District in order to pay for the operating expenditures during the Fiscal Year.

#### **Clubhouse Rentals Revenues**

The District will collect fees for room rental of the amenity center.

#### Interest

The District earns interest on the monthly average collected balance for each of their investment accounts.

**Expenditures - Administrative** 

#### **Supervisors Fees**

Chapter 190 of the Florida Statutes allows for members of the Board of Supervisors to be compensated \$200 per meeting in which they attend. The budgeted amount for the fiscal year is based on all supervisors attending 12 meetings.

#### **FICA Taxes**

Payroll taxes on Board of Supervisor's compensation. The budgeted amount for the fiscal year is calculated at 7.65% of the total Board of Supervisor's payroll expenditures.

#### **District Engineering Fees**

The District's engineer will provide general engineering services to the District, i.e. attendance and preparation for monthly board meetings, review of invoices, and other specifically requested assignments.

#### **District Counsel Fees**

The District's Attorney, will be providing general legal services to the District, i.e., attendance and preparation for monthly Board meetings, review of contracts, review of agreements and resolutions, and other research assigned as directed by the Board of Supervisors and the District Manager.

#### **Annual Audit**

The District is required to conduct an annual audit of its financial records by an Independent Certified Public Accounting Firm. The budgeted amount for the fiscal year is based on contracted fees from the previous year engagement plus anticipated increase.

#### **Assessment Roll Administration**

GMS-NF, LLC provides assessment services for closing lot sales, assessment roll services with the local Tax Collector and financial advisory services.

#### **Dissemination Agent**

The District is required by the Security and Exchange Commission to comply with Rule 15(c)(2)-12(b)(5), which relates to additional reporting requirements for un-rated bond issues.

#### Arbitrage Rebate

The District is required to annually have an arbitrage rebate calculation on the District's Series 2016 A1 and A2 Special Assessment Revenue Refunding Bonds. Currently the District has contracted with Grau & Associates, an independent certified public accounting firm, to calculate the rebate liability and submit a report to the District.

#### **Trustee Fees**

The District bonds will be held and administered by a Trustee. This represents the trustee annual fee.

#### **District Management Fees**

The District receives Management, Accounting and Administrative services as part of a Management Agreement with Governmental Management Services-NF, LLC. The budgeted amount for the fiscal year is based on the contracted fees outlined in Exhibit "A" of the Management Agreement.

#### Information Technology

The District processes all of its financial activities, i.e. accounts payable, financial statements, etc. on a main frame computer leased by Governmental Management Services – NF, LLC.

#### Legal Advertising

The District is required to advertise various notices for monthly Board meetings and other public hearings in a newspaper of general circulation.

#### Bank Fees and Other Charges

This includes monthly bank charges and any other miscellaneous expenses that incur during the year.

#### **Office Supplies**

Supplies used in the preparation and binding of agenda packages, required mailings, and other special projects.

The District is required to pay an annual fee to the Florida Department of Commerce for \$175.
